2. REVIEW THE DIRECTOR'S FEBRURAY 4th BI-WEEKLY REPORT:

Fairbanks Community Center Project

Director Roy stated that both he and Chairman Sheldon had drafted a Memorandum of Understanding (M.O.U.) proposal letter to Henry Hayes, Sudbury's Town Manager for the Fairbank Community Center project, and the responsibilities and costs related to relocating the water main. Mr. Roy stated that the cost of the water main portion of the project is approximately \$260,000, which includes removal and disposal of the old 10-inch asbestos cement water main. Mr. Roy stated that the District's proposed contribution is about \$75,000. The draft has been presented to Town Manager Henry Hayes and Select Board Chair Jennifer Roberts for their review. Mr. Roy also informed the Commissioners that the next meeting to discuss this topic is scheduled for Monday, February 14th, and that both he and Chairman Sheldon would be representing the District to discuss the matter with the Town Manager and the Select Board Chair.

There were no further questions regarding the Director's report.

3. PRESENTATION OF FY23 DRAFT BUDGET:

Director Roy presented the FY23 draft budget to the Commissioners for their review. Several specific line items were discussed, and the final approval of the budget was deferred to the next scheduled Commissioners meeting, pending some updates from Mr. Roy.
