

Pursuant to the Warrant dated the 23rd day of March 2021 signed by Joshua M. Fox, Robert H. Sheldon and Robert E. Boyd, Jr., Board of Water Commissioners, served according to law by Susan O'Connor, District Clerk, the Annual Meeting of the Sudbury Water District of Sudbury was held at the Sudbury Water District, 199 Raymond Road, Sudbury, Massachusetts, on May Eighteenth, Two Thousand Twenty-One.

The meeting was called to order at seven o'clock in the evening, a quorum being present. Craig E. Blake, District Moderator, announced that he had examined the call of the meeting and District Clerk's return of service and found them to be in order.

At that time, the Moderator read to the meeting a letter from the Massachusetts Department of Revenue, Division of Local Services indicating the amount of "free cash" as of July 1, 2021, for the Sudbury Water District was \$2,507,686.00

Introduction of the persons sitting at the head table from left was as follows: Vincent J. Roy, Executive Director, Joshua M. Fox, Robert H. Sheldon, Robert E. Boyd, Jr., Board of Water Commissioners, Thomas S. Travers, Treasurer, Karen A. Moretti, Office Manager/Assistant Treasurer, Richard Hingston, CPA, Lawson Williams, Counsel, Susan O'Connor, District Clerk; Renee Adams, Customer Service Manager. Unanimous consent was given for any non-member of the Sudbury Water District at the head table to speak to answer any questions that may arise.

A motion was made to dispense with the reading of the call of the meeting, the Clerk's return of service, and the text of the articles. The motion was seconded and passed by a unanimous vote.

Article 1. To hear and act on report. Seconded Upon a vote by show of cards, it was a:

UNANIMOUS VOTE: "That the following reports be accepted as printed in the warrant for this meeting, as amended, subject to the correction of errors as and when found." (1) Record of the May 18, 2021, Annual Meeting. (2) Record of the May 18, 2021, Special Meeting.

The Board of Water Commissioners is pleased to present the following report summarizing the District's activities during the Fiscal Year ending 2021 for inclusion in the Minutes of this Annual Meeting of the Sudbury Water District.

SUDBURY WATER DISTRICT "STATE OF THE DISTRICT – 2021"

The Sudbury Water District's Annual Meeting is underway, and we welcome you and thank you for your attendance. First, I should mention the passing of Bob Coe this past October. Bob was moderator for the Water District for at least 25 years, more than had been noted in his obituary. He was a dedicated member of the District and resident of the Town. On a personal note, he and I were neighbors, we rode the train together, and we served the Water District together for many years. He certainly will be missed.

I'd like to acknowledge and thank the District's hard-working staff, both the field crews and office staff. Together they do an incredible job of both monitoring and maintaining our physical infrastructure and maintaining the District's financial well-being. We have an excellent water system, our bond rating remains AAA, and our other post-employment benefits status is well ahead of where we have to be to address retiree health expenses.

This has been a very unusual year, with the pandemic changing the way that we meet, interact with each other, and interact with the public. Despite the challenges, we've been able to keep up with the demands. We're very close to having all of our staff 100% vaccinated. We look forward to opening our doors for face-to-face business with customers soon, and we appreciate your cooperation. That said, it's quite incredible what we've managed to do this past year. Here are the highlights.

We replaced about a mile of outdated water main with new ductile iron pipe, including replacement water main on Codjer Lane and Morse Road. We integrated Well 3 into the East Street Water Treatment Facilities, which previously only treated Wells 8 and 10. We replaced all the commercial water meters. We identified and addressed a potential threat to our East Street Water Treatment Plant wells as a result a beaver dam raising Hop Brook elevation, which could put our wells in the area under the direct influence of surface water. We prepared a Risk and Resiliency Plan to identify the District's vulnerabilities and how to minimize them. In fact, Executive Director Roy was a co-presenter of a talk to the local chapter of the American Public Works Association. I was able to sit in on that talk, and it was impressive to see other utilities asking questions of him and hear what the District was doing as an example for them. We also prepared a Water Master Plan, which is an in-depth look at the District's infrastructure, how the systems work, and what the District needs for improvements. That study concluded with a prioritized list of projects, looking well into the future.

Two significant projects have emanated from the Water Master Plan, improvements to our system's monitoring and control system – our SCADA system – and development of a high-pressure zone for the consumers located at higher elevations. SCADA improvements will enhance cyber security, improve water quality through better control of the water in our storage tanks, and better enable us to monitor and control the system as a whole. The high-pressure zone project will begin as a study, in conjunction with the evaluation of how best to replace the Goodman Hill Water Storage Tank. The water storage tanks in our system are all currently at the same elevation, which sets the pressure of the water in homes and businesses. Homes and businesses located at lower elevations have higher pressure water, whereas homes located at higher elevations such Goodman Hill and Willis Hill, have much lower pressure. A dedicated high-pressure zone using a booster-pump system will better serve the homes and improve fire-fighting capabilities at the higher elevations. The District has continued to work with the Town on aspects of the Quarry North development. We've reviewed plans for the wastewater treatment and disposal system, especially in light of the potential effects on our Well 5. Also related to that project, we acquired an eight-acre parcel of land from the Town, near our Wells 4 and 6 off Raymond and Warren Roads, to preserve the water quality of the Raymond Road Aquifer and to provide a potential site for a replacement well if needed. That land was in exchange for the land the District gave to Quarry North for its development as part of the arrangement with the Town. The District has also received about \$650,000 as our share of the negotiated agreement between Quarry North, the Town, and the District.

Those of you who travel on Dutton Road will have seen the signs for the construction on the bridge over Hop Brook, scheduled to start on the 1st of June. The District and Town have worked together on this project so that the District can replace our old water main as an integrated part of the construction, rather than risk having to perform expensive excavation to repair or replace the main in the future.

The final project I want to bring to your attention is the District's water system and per- and polyfluoroalkyl substances, commonly referred to as PFAS compounds. These are the "forever" compounds that have been very much in the news recently. The District issued a press release on April 29, and we have quite a bit of information on the subject on our website, sudburywater.com. Later, we'll be voting on three articles associated with the appropriation of funding for PFAS treatment. We'll discuss the topic further when those articles are presented for consideration, but I'd like to provide you with an update on regulations, PFAS in our water supply, and what actions we've taken and are planning to take with regard to PFAS:

- The US EPA does not have a regulatory limit for PFAS in drinking water and will probably not for several years, although they did establish a non-binding health advisory limit of 70 parts per trillion. Massachusetts has established a regulatory maximum concentration limit (MCL) of 20 parts per trillion for the sum of six specific PFAS compounds. Massachusetts is one of only six states in the country to have PFAS regulations for drinking water. Those states are all in the northeast, except for Michigan, and each state's regulations are different from one another.
- The District first tested for PFAS in 2013, and the concentrations were below detection limits. However, analytical techniques have become much more sophisticated since then, enabling detection limits to be much lower. In January 2020, the District, voluntarily began evaluating our water system for PFAS, working with the Sudbury Board of Health. We sampled and analyzed quarterly and are now doing so monthly. We will continue to monitor our system on a monthly basis going forward and report the results to MassDEP.
- The PFAS results have varied somewhat, but the concentrations have remained below the MassDEP's MCL of 20 parts per trillion, staying roughly in the 15 parts per trillion range, and it's been pretty uniform throughout both the Raymond Road and Pratts Mill Aquifers. It's difficult to point to any specific source within Sudbury.
- We've maintained and continue to maintain close communications with MassDEP and the Sudbury Board of Health (and other Town boards and groups) to keep everyone aware of our findings and plans.
- · We hired Weston and Sampson, experts in PFAS monitoring and treatment, to

advise us on the subject.

- Weston and Sampson's team has worked with the District to prepare a study summarizing findings to date and prescribing a plan for building granular activated carbon (GAC) treatment facilities at our two treatment plant sites.
- Weston and Sampson also helped us apply for a MassDEP grant, and we were fortunate to have received \$111,169 to help offset the cost of design of treatment facilities and they've already begun the design of the Raymond Road Water Treatment Facility's PFAS treatment add-on, using the MassDEP funds.
- We have put financial plans in place for funding the construction of the new treatment facilities. Those plans will require approval of transfers and bonding articles at tonight's meeting.
- Throughout the past year and a half, Executive Director Roy, his staff, and I have attended training sessions and presentations on PFAS, and we've toured PFAS treatment facilities with Weston and Sampson to better understand what can be done and how our system can be retrofitted most effectively and efficiently.

We're well into the design of the PFAS treatment add-on to the Raymond Road Water Treatment Facilities, much of which can then be used for the design at the East Street Water Treatment Facilities. There are some long-lead items, such as concrete pads and piping that are relatively inexpensive but are wise investments to enable rapid deployment of treatment. We're also looking into the pre-purchase of carbon containers, which currently have a lead time of about 22 weeks. The PFAS treatment will be an addition to the existing water treatment facilities at Raymond Road and at East Street, where we remove iron and manganese in the water, largely for aesthetic purposes to minimize discoloration and staining. That's an advantage for us, because PFAS treatment needs to have iron and manganese removed to be effective and not plug up the carbon beds. So, we've got the necessary pretreatment in place already at both plants. The Raymond Road Water Treatment Facilities are capable of meeting the average demands of the District, whereas the East Street Water Treatment Facilities are a little smaller and are not capable of fully handling the average demands of the District. Because of that, we have prioritized development of PFAS treatment for Raymond Road's plant first, then followed by the East Street PFAS plant.

I'm sure there are a lot of question on this matter. PFAS compounds are hard for us to avoid, even if all drinking water was 100% free of them. They've been around since the 1940s and are in food packaging, clothing, non-stick cookware, ski wax, fire-fighting foams, and even in rainwater. Even though there are multiple exposure pathways to PFAS, regulatory authorities are focusing on what can be done specifically with public drinking water supplies, and the District wants to stay well in front of the situation and not have to face an emergency such as other communities have had to face already.

We thank you again for coming out tonight, and we look forward to working with you to review and vote on the articles being presented to you in the annual and special meetings.
