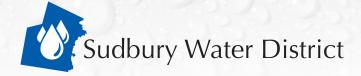

RECORD OF THE 87th ANNUAL MEETING

The Sudbury Water District Sudbury, Massachusetts

Sudbury Water District 199 Raymond Road Sudbury, Massachsuetts May 16, 2023 Election 3:00 p.m. - 7:00 p.m. Meeting 7:06 p.m.

Pursuant to the Warrant dated the 31st day of March 2023 signed by Joshua M. Fox, Robert E. Boyd, Jr., and Robert H. Sheldon Board of Water Commissioners, served according to law by Susan O'Connor, District Clerk, the Annual Meeting of the Sudbury Water District of Sudbury was held at the Sudbury Water District, 199 Raymond Road, Sudbury, Massachusetts, on May Sixteenth, Two Thousand Twenty-Three.

The meeting was called to order at 7:06 in the evening, a quorum being present. Craig E. Blake, District Moderator, announced that he had examined the call of the meeting and District Clerk's return of service and found them to be in order.

At that time, the Moderator read to the meeting a letter from the Massachusetts Department of Revenue, Division of Local Services indicating the amount of "free cash" as of July 1, 2022, for the Sudbury Water District was \$2,417,030.00.

Introduction of the persons sitting at the head table from left was as follows: Vincent J. Roy, Executive Director, Lawson Williams, Counsel, Joshua M. Fox, Robert H. Sheldon, Robert E. Boyd, Jr., Board of Water Commissioners, Thomas S. Travers, Treasurer, Karen A. Moretti, Office Manager/Assistant Treasurer, Susan O'Connor, District Clerk, Renee Adams, Customer Service Manager, Jennifer Mazzocchi, Administrative Assistant. Unanimous consent was given for any non-member of the Sudbury Water District at the head table to speak to answer any questions that may arise.

A motion was made to dispense with the reading of the call of the meeting, the Clerk's return of service, and the text of the articles. The motion was seconded and passed by a unanimous vote.

Article 1. To hear and act on report. Seconded Upon a vote by show of cards, it was a:

The Board of Water Commissioners is pleased to present the following report summarizing the District's activities during the Fiscal Year ending 2022 for inclusion in the Minutes of this Annual Meeting of the Sudbury Water District.

SUDBURY WATER DISTRICT "STATE OF THE DISTRICT – 2023"

Good evening and welcome to this year's annual and special meetings of the Sudbury Water District.

Financially, we remain in excellent standing, and we continue to move forward with our measures to meet other post-employment benefits (OPEB) funding and to begin building a pension stabilization fund.

This has been a year of considerable staff changes. Two of our long-time employees, Pat Carroll, and Bob Gassett, retired last summer. We miss them and their knowledge of the ins and outs of our extensive system, but their retirements are well deserved, and we wish them the best in a more relaxed lifestyle. A few months ago, Cam Adams also left us after being accepted into the Massachusetts State Trooper school, where he's now pursuing a new career that's been a long-time dream job for him. Cam had worked for the District part time in high school and in college and then as a full-time employee for almost five years. We'll miss him and wish him the best.

We hate to see these highly skilled, good people leave, and it means searching for new people to fill the vacant positions. Executive Director Roy worked hard to do so and has succeeded. We welcome three new employees since last year. Jeff Monahan and Nigel Dwarika, both joined us last September. Jeff right away entered training that has led to him obtaining his Distribution-2 license. Nigel is now our Cross Connection Control Coordinator. He too started right away with further training, and he has now obtained his Treatment-1 license. Our third new employee, Mike LaCroix, joined last month as a laborer, and we're excited to have him, working with a great group of people to start him off in the water industry.

Training and continuing education keep the District running at its optimum and enable employees to acquire requisite technical licenses and maintain credentials for those licenses. In addition to Jeff's and Nigel's training and staff attendance at conferences and seminars, Vincent Roy, Karen Moretti, and Jennifer Mazzocchi all completed Massachusetts Certified Public Purchasing Official (MCPPO) training. And Mike Abbondanzio is in the Massachusetts Municipal Association – Suffolk University Local Government Leadership and Management Certificate Program, and he's scheduled to receive that hard-earned certificate at a ceremony on June 27. We're very proud of our employees, their commitment to excellence and desire to learn.

PFAS compounds, the "forever chemicals," remain a top concern facing every water supplier in the country. At the District, we sample and analyze water monthly for PFAS, and we are fortunate that the levels in our water consistently remain below the state's maximum concentration limits. However, we need to be as pro-active as possible, which has led to the PFAS treatment facilities at the Raymond Road and East Street Water Treatment Plants. The Raymond Road PFAS plant is just beginning construction. The East Street PFAS plant is nearing completion of design. These plants are both eligible for state revolving loan fund (SRF) zero-percent interest loans for construction. Zero interest is an unbeatable rate, but new treatment is nonetheless a major investment and the bidding climate these days is highly unpredictable. We were fortunate to receive bids for the Raymond Road plant that were lower than the engineer's estimate, but the latest cost estimate for the East Street plant is higher than had been originally planned, and Article 11 on the warrant tonight asks for funds to cover that higher estimate. This increase is due to three major factors. First, there is a constant trend towards more stringent treatment requirements, as evidenced by the proposed US EPA federal regulations, and that led us to a larger building footprint for space for future polishing

treatment if needed. Second, we will be replacing pumps at Wells 3, 8, and 10 as part of the project to be sure there is sufficient pressure to push water through the new PFAS filters. All those wells are due for upgrades soon, and we thought it prudent to expand the scope of work accordingly and take advantage of the zero-percent loan. Third, the detailed design determined that the treatment system requires a full separate building to house filters and piping, not just an addition to the existing treatment plant building. Cramming piping and equipment into a tight space would have been impractical for operations and maintenance.

In further news on the PFAS front, the District continues as a participant in a multidistrict litigation against the manufacturers of aqueous film forming foam, working with our counsel, SL Environmental. That litigation is moving forward with the current focus on the bellwether case involving the City of Stuart, Florida. If the MDL and the Water District are successful, some or all the money spent on PFAS monitoring and treatment can be recovered.

Within the past year, the MWRA has begun discussions with some non-MWRA MetroWest communities about joining the MWRA, at least for emergencies. The MWRA has very low, mostly undetectable, PFAS concentrations in its supply and has the capacity to expand its system to new communities. The current discussion affecting Sudbury revolves around a proposed 48-inch diameter pipeline that would originate in Framingham and then would be routed through Framingham, Sudbury, Concord, and perhaps as far north as Lowell. Branches would split off from that 48-inch main to supply Maynard, Hudson, Stow, and others along the way. If that extension of the MWRA's system were to come to fruition, the District is interested in having an emergency connection, but only for emergencies. Purchasing MWRA water will cause rates to increase appreciably, based on an analysis of neighboring communities where MWRA water is the sole source of supply. Also, the MWRA's plan for redundancy when the pipeline is out of service is to use "local supplies," which would mean the District's existing supply would be necessary no matter what. There are still a lot of unanswered questions and both the District, and the Town have been in regular meetings with the MWRA and neighboring communities, the District as the local water supplier and the Town as the owner of property and roadways through which a transmission pipeline would have to be located. When will this expansion happen? The logistical challenges appear to be substantial and ironing them out will take years. So, for now, stay tuned....

As for our more routine activities, we continue to search for leaks in our system, and once again this year we are working with a specialist in leak detection. In terms of flushing, we're only flushing dead ends this year, and that effort includes installing new hydrants at dead end streets where they're missing. We have about 30 hydrants to install in total, and this next year we plan on installing 15.

Vin and his staff continue to coordinate reviews of projects with the Town. Vin has also had one comprehensive meeting with Andrew Sheehan, the new Town manager, discussing respective projects and how to keep them coordinated and appropriately sequenced. We look forward to working with Mr. Sheehan and a continued strong relationship with the Town departments, boards, and commissions.

Thank you to the Water District staff for once again organizing and running this annual gathering and transforming the garage into a meeting room.

And thank you, District members, for taking the time to participate in these annual and special meetings with us.

The Annual Meeting resumed at 7:23 p.m.
