- A Water Contractor license does not constitute a blanket General Water Permit application. A General Water Permit application is required for each project and shall be submitted along with required documents, accompanied by the required deposit, and approved by the District prior to any excavation related to and affecting the District's public drinking water system.

The Sudbury Water District reserves the right to suspend or revoke any license for cause, including, without limitation: operation with a suspended or expired Massachusetts Hoisting Engineer license; engagement in unsafe or improper construction practices; submission of false or misleading information; failure to maintain required liability insurance or willful or negligent violation of the District's rules, regulations, or policies. The Applicant further agrees to indemnify, defend, and hold harmless the District, its Commissioners, officers, employees, and agents from and against any and all claims, liabilities, damages, losses, costs, or expenses arising from or relating to the work performed, and accepts full responsibility for the performance, safety, and legality of such work. This agreement shall survive the completion of the work and any acceptance thereof by the District.
